#### DR WALID JAMMAL MBBS FRACGP DCH M. Health Law

Dr Walid Jammal is a GP in Western Sydney. His interests include paediatrics, men's health, ethics and health law. He has a strong commitment to quality and safety in health care, as well as health system policy and reform. He has been involved with testing and developing integrated care models for many years, both with NSW Health and the Commonwealth.

He is Co-Chair of the GP Advisory Group for the Agency of Clinical Innovation, was Co-Chair of the Commonwealth's Primary Care Reform Steering Group, is a Member of the Medicare Services Advisory Committee (MSAC), Board member of the Western Sydney LHD, and a Board Member of WentWest (Western Sydney Primary Health Network). He is also a member of the Commonwealth's Strengthening Medicare Taskforce.

He has a keen interest in health economics and integrated models of care including the Patient Centred Medical Home frameworks.

Walid is also Clinical Lecturer at the University of Sydney and Conjoint Senior Lecturer, School of Medicine, Western Sydney University.





#### DR KIRSTEN MEISINGER MD, MHCDS

Health System Transformation experience: Dr. Meisinger is an international expert on Patient Centered Medical Homes and healthcare system transformation. She was National Faculty Co-Chair for the Centers for Medicare and Medicaid Services (CMS) initiative "Transforming Clinical Practices Initiative" (TCPi), an initiative which transformed over 140,000 US practices to value-based, patient centered medical care. She was co-chair of the National Health Equity Collaborative (sponsored by NCQA) and a member of the expert panel for the Health Care Homes initiative in Australia. Currently she is helping design and implement a national pilot for Primary Care transformation in the private sector in Brazil.

Clinical and Operations Leadership: Kirsten Meisinger is a Regional Medical Director, Medical Director of Sexual and Reproductive Health, and Primary Care Lead for Telehealth at the Cambridge Health Alliance. She cares for an active Family Medicine panel at the Union Square Family Health Center, an award winning Patient Centered Medical Home practice that was selected as one of the top 30 Ambulatory care sites in the US by the Robert Wood Johnson Foundation in 2010.

**Academic:** Dr. Meisinger leads the System Transformation team at the Harvard Center for Primary Care, at Harvard Medical School. She is an accompanier at Wellbeing and Equity in the World, an organization devoted to advancing wellbeing and equity in partnership with those most affected by inequities by designing cross sector collaboration. She has faculty appointments at Harvard Medical School, Tufts University, The MGH Institute of Health Professions, Tiradentes University, Brazil, and the Latin America Team at the Institute for Healthcare Improvement (IHI).

**Education:** Dr. Meisinger earned a BA from Brown University, her medical degree from Case Western Reserve University, a Family Medicine Residency at the Greater Lawrence Family Health Center in Lawrence, Massachusetts, and a Master in Health Care Delivery Science degree from Dartmouth.
